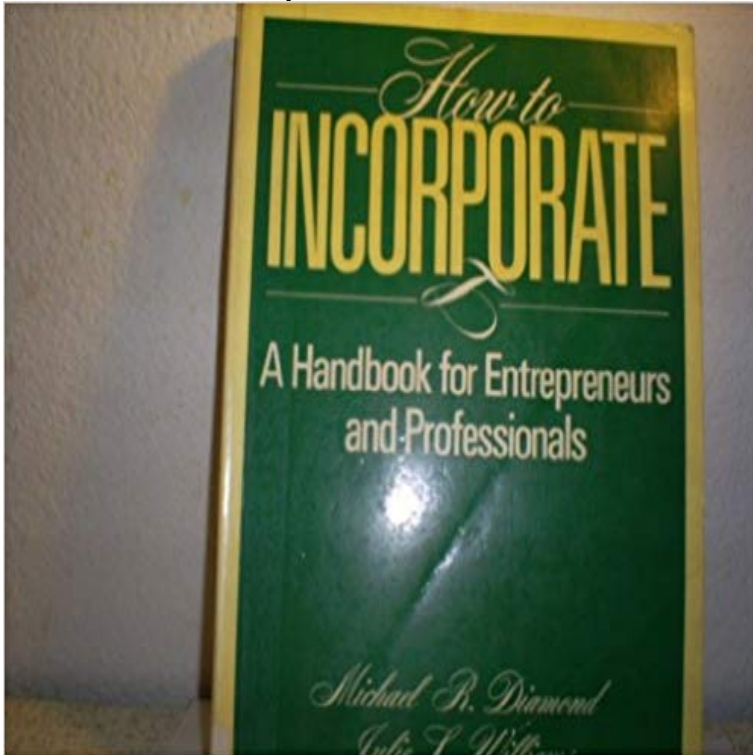


How To Incorporate: A Handbook for Entrepreneurs and Professionals
