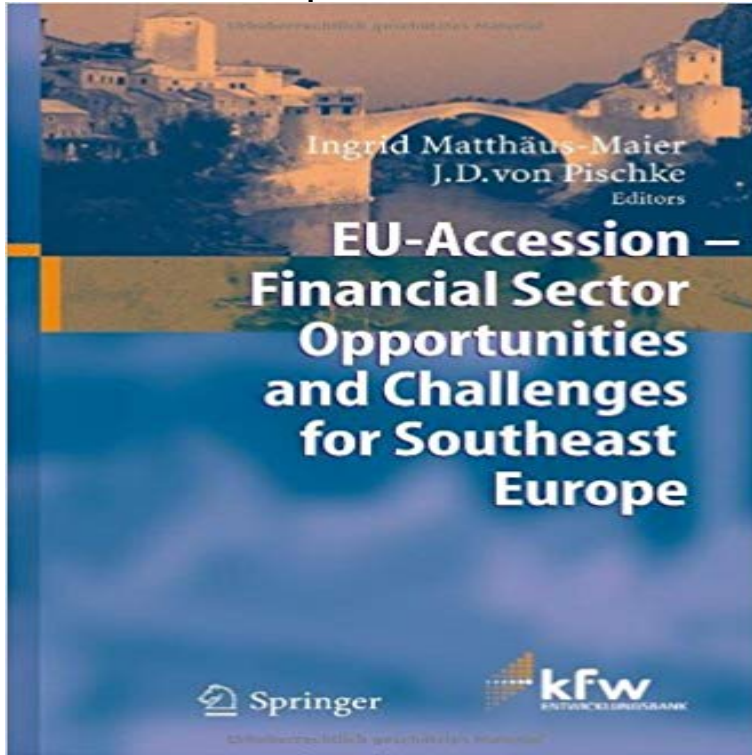


# EU Accession - Financial Sector Opportunities and Challenges for Southeast Europe
